Since 2001, Western Boone School Lunch Program has utilized a third party to perform purchasing services for food service supplies, materials and equipment that meet or exceed all State and Federal procurement guidelines, regulations and laws. HPS (Gordon Food Service) has been awarded this third party purchasing program agreement since Western Boone opted into utilizing this type of service in order to assist in keeping our costs lower.

We are required every five years to solicit sealed responses from qualified firms who perform third party purchasing. Request for Proposals (RFP) were submitted to three different third party purchasing firms: HPS, Amerinet and Consorta.

We received one response which was from HPS. HPS offers semi-annual credit memos to members calculated at 1.25% of the total purchases during each 6-month period. Plus, they have added a new incentive of an additional .25% with commodity entitlements. They also offer a 1% discount on every invoice if it is paid within 10 days of receipt.

I would like to ask that the board accept the HPS Proposal for Third Party Purchasing Services for the Western Boone School Lunch Program.

With the adoption and subsequent purchase of a new elementary reading program, elementary textbook fees will increase at most grade levels in 2013-2014. Though most grade levels will undergo an increase, textbook fees in grades 4 and 5 will decrease due to the selection of a lower-cost science/health supplement.
