















SEA 35



SEA 35- Financial Literacy

- Provides that, beginning with the cohort of students who are expected to graduate from a public school, a charter school, or a state accredited nonpublic school in 2028, an individual must successfully complete a personal financial responsibility course (course) before the individual may graduate. (2023-2024 8th Grade Students at Western Boone)
- Creates requirements for content that must be covered in a course.
 Provides that a public school, a charter school, or a state accredited nonpublic school must offer instruction on a course as a separate subject.
 Provides that the state board may allow a course to satisfy one or more diploma course requirements.



SEA 35- Financial Literacy

- Personal Finance is already offered as an elective course for students at Western Boone, with one section during the second semester.
- The plan is to expand the Personal Finance elective option into a requirement for students.
 - 8th/9th grade students will take PCC (Local Requirement)
 - 10th/11th grade students will take Personal Finance (State Requirement)
 - 12th grade students will take Econ (State Requirement)





- At Western Boone Junior Senior High School, our goal is to increase SAT Proficiency on the Digital SAT in Math to 65% or higher over a 3-5-year period (we are currently awaiting scores for year 2).
- We have implemented instructional strategies and supplemental support curriculum to help reach that 65% or higher proficiency, as well as audited Math sequencing in order to meet the school goal and maintain our high graduation rate expectation.
- As a result of our math sequencing review, it has been decided that we will offer a new course called "Analytical Algebra II."



- From the Indiana Department of Education on Analytical Algebra II
 - The Indiana Academic Standards for Analytical Algebra II consist of six domains: Arithmetic and Structure of Expressions, Equations, and Functions; Function Families; Modeling with Functions and Data; Modeling with Advanced Algebra; Modeling with Data and Statistics; and Modeling with Quantities. The skills listed in each domain indicate what students should know and be able to do by the end of the course. The Process Standards demonstrate the ways in which students should develop conceptual understanding of mathematical content, and the ways in which students should synthesize and apply mathematical skills.




- From the Indiana Department of Education on Analytical Algebra II
 - Analytical Algebra II builds on previous work with linear, quadratic and exponential functions and extends to include polynomial, rational, radical, logarithmic, and other functions. Data analysis, statistics, and probability content should be included throughout the course, as students collect and use univariate and bivariate data to create and interpret mathematical models. Additionally, Analytical Algebra II should focus on the application of mathematics in various disciplines including business, finance, science, career and technical education, and social sciences, using technology to model real-world problems with various functions, using and translating between multiple representations. The eight Process Standards for Mathematics apply throughout the course. Together with the content standards, the Process Standards prescribe that students experience mathematics as a coherent, useful, and logical subject that makes use of their ability to make sense of problem situations. This course is not recommended for students interested in pursuing a STEM degree at a four year institution; this course may not prepare students for PreCalculus/Trigonometry.

- Why would changing the math sequencing benefit students and help the school as a whole reach our data goal?
 - All students will be enrolled in a math course with material similar to what they will be exposed to on the Digital SAT their Junior year (Pre-Cal/Trig, Algebra II, or Analytical Algebra II).
 - Currently, many Juniors are enrolled in either Geometry or an off-sequence math course to earn their credits.
 - Analytical Algebra II is an option for students struggling with Algebra concepts that can not only get a more in-depth reteach of skills but be exposed to real-world explorations of Math concepts.
 - With students in Analytical Algebra II, other courses (like Algebra II) could work at a more rigorous pace.

ILEARN Pilot/NWEA



ILEARN Pilot/NWEA

- The ILEARN assessment has been redesigned to include a new, shortened summative assessment at the end of the school year, with added "checkpoints."
- Check points will be administered throughout the school year in order to better measure students' progress on newly identified essential standards.
- All schools will be required to move into this model starting with the 2025-2026 school year, with the 2024-2025 school year being an optional pilot year.
- At the Junior High School, the decision was made to transition into the pilot for 2024-2025, which will be the data points utilized in Professional Learning Communities for Math and ELA, grades 7-8, next school year. Junior High School students will not take NWEA next school year.
 - Grades 9, 10, and 11 will still take NWEA as a way for teachers to inform instruction and predict performance on PSAT/SAT
