## **BOND REFUNDING RESOLUTION**

Mr. Frandsen reviewed for the Board the actions taken by the Western Boone Multi-School Building Corporation for the refunding of the First Mortgage Refunding Bonds, Series 1998 and First Mortgage Bonds, Series 1999 of the Western Boone County School Bldg. Corp. (the "1998 Corporation"). He then presented to the Board for its consideration (i) a Second Amendment to Contract of Lease to the Contract of Lease executed by the Board on March 1, 1994, which proposes to amend Section 2 of said Lease, and (ii) an Amendment to Lease to the Lease Agreement executed by the Board on March 30, 1999, which proposes to amend Section 2 of said Lease. It is anticipated that the 1998 Corporation will agree to assign its interests in the Leases to Western Boone Multi-School Building Corporation.; and

After a full discussion, upon motion duly made, seconded and unanimously carried, the following resolution was adopted:

RESOLVED, that the Amendments to Leases between Western Boone County Community School Corporation (the "School Corporation"), as lessee, and Western Boone Multi-School Building Corporation, as assignee of Western

Boone County School Bldg. Corp. (the "1998 Corporation"), as lessor, submitted to this meeting, be and the same hereby is approved.

RESOLVED FURTHER, that the Secretary is authorized and directed to initial and date a copy of the proposed Amendments to Leases submitted this day to the Board of School Trustees and to place the same in the minute book immediately following the minutes of this meeting, and said Amendments to Leases is made a part of this resolution as fully as if same were set forth herein.

RESOLVED FURTHER, that the Amendments to Leases shall be executed by the President and attested by the Secretary.

RESOLVED FURTHER, that the form of the Continuing Disclosure Undertaking is hereby approved and the President and Secretary are authorized to execute such agreement.

RESOLVED FURTHER, that it is hereby determined to be proper and in the public interest to approve the

incorporation of the Building Corporation known and designated as the Western Boone Multi-School Building Corporation for the purpose of financing, refinancing, constructing and equipping certain school facilities and leasing same to this School Corporation.

RESOLVED FURTHER, that the issuance, sale and delivery by the Building Corporation of bonds designated Western Boone Multi-School Building Corporation "First Mortgage Refunding Bonds, Series 2008" in the aggregate principal amount of approximately \$14,225,000, is hereby approved.

RESOLVED FURTHER, that this Board of School Trustees hereby approves the existing Directors to continue to act as Directors of the School Building Corporation.

RESOLVED FURTHER, that the officers of this School Corporation are hereby authorized on behalf of this School Corporation to approve and execute any certificates and documents on behalf of the School Corporation in connection with the refunding of the First Mortgage Refunding Bonds, Series 1998 and First Mortgage Bonds, Series 1999 of the 1998 Corporation.
